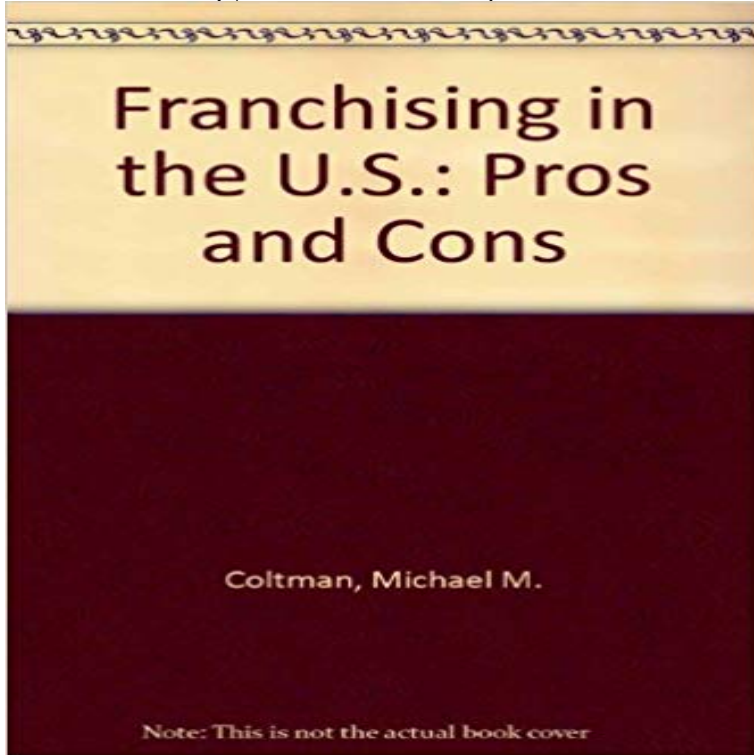


Franchising in the U. S. (Self-Counsel Business (Paperback))
