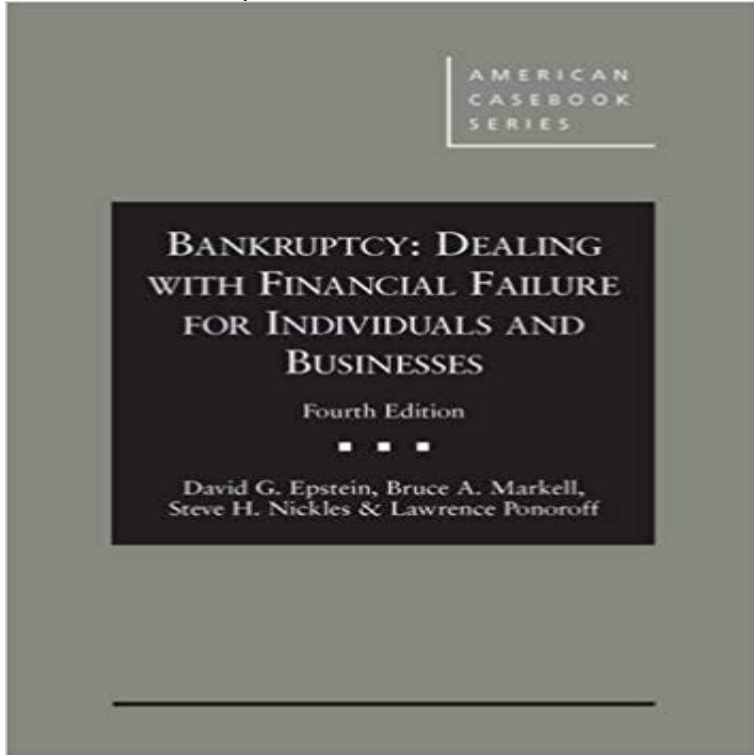


Bankruptcy: Dealing with Financial Failure for Individuals and Businesses (American Casebook Series)
