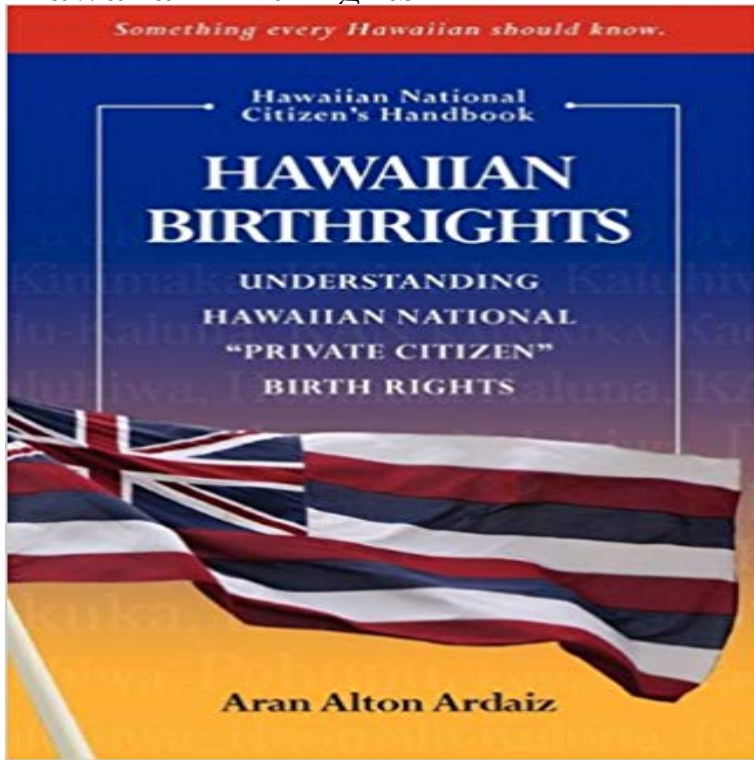


Hawaiian Birthrights
